CORONAVIRUS TESTING- UPCOMING CHANGES

This is to remind you of COVID -19 testing for all Employees and Essential Caregivers on Monday, February 1st. If you have not tested within the last week, you will need to wait for your results prior to visiting or working. Please call Sam Finch, 998-7396 or Dawn Bratlien at 998-7313 with any question of concerns. **Testing is mandatory.** We



are expecting Essential Caregivers who wish to visit and all Employees on and off duty that day to be present for testing. If you do not test on this date, you will be responsible to find alternate testing. You will **not** be able to work or visit until you have been tested.

Following our Coronavirus testing on February 1st we will be cutting back on testing to once a month. This change is fluid and dependent on several factors that will continue to be monitored closely.

Beginning Thursday January 28th entry screening into all LB Homes buildings will no longer be considered "Active" screening. ALL visitors and staff members are required to screen themselves in and will be held accountable for following all appropriate steps during the screening process. Please follow the screening instructions carefully and do not hesitate to ask questions.
