# Visitation - What to know?

We have been informed of a positive case of COVID-19 in our LB Broen Home facility. With a COVID-19 case, we will need to stop general visitation at this time. LB Broen Home doors will be locked. Essential Caregiver visits may continue for all residents except those on Transmission Based Precautions. Compassionate Care visits may continue. As a reminder, Essential Caregivers will need to screen in thoroughly, and wear a surgical face mask while being escorted to and from the resident's room. The Essential Caregiver is limited to the resident's room.

Thank you for your continued support and diligence as we navigate these guidelines provided by the Minnesota Department of Health. ## **CORONAVIRUS TESTING:**


We are currently conducting outbreak testing for staff and residents at LB Broen Home. Please watch your emails and listen to voice messages for updates regarding testing requirements. If more positive cases are identified, testing will be increased. We appreciate your help to contain the virus! Essential caregivers are strongly encouraged to continue testing with us however this is no longer required to be able to visit.

- In outbreak testing, due to the delta variant being very contagious, at this time we will be testing all staff
   (who enter Broen Home to work) every other day x3 and then resume twice weekly testing. Please
   make every effort to test at these times. If you are unable to test on Saturday, Monday, Thursday of this
   week or Monday and Thursday of next week, please contact Sam Finch at 998-7336 or Dawn Bratlien
   at 998-7313.
- This is to remind you of COVID -19 testing that is mandatory for <u>ALL LB Broen Home staff & residents</u>, and all <u>unvaccinated</u> LB Hospice, Home Care, and business office employees, and recommended (but not required) for Broen Essential Caregivers on <u>Monday</u>, <u>September 13<sup>th</sup> and Thursday</u>, <u>September 16<sup>th</sup> from 6:00am—9am in the <u>2N Dining room</u>, near Light and Life Auditorium.
