Outbreak procedures can be initiated with the notice of just one COVID-19 positive staff member or resident. In outbreak testing we will test all staff, twice weekly, regardless of vaccination status. When we are out of outbreak testing, we will resume testing all unvaccinated staff, twice weekly.

Current Visitation Information

We continue our mitigation efforts which include screening for symptoms upon entering an LB facility, wearing of masks appropriately, frequent hand-hygiene and 6-foot distancing as appropriate. Staff and Essential Caregivers should also wear eye protection appropriately.

As a reminder, Essential Caregivers will need to screen in thoroughly, and wear a surgical face mask while being escorted to and from the resident's room. The Essential Caregiver is limited to the resident's room.
